

## AMENDMENT TO ARTICLES OF ORGANIZATION OF PEREGRINE INTERNATIONAL, LLC

WHEREAS, the Articles of Organization for PEREGRINE INTERNATIONAL, LLC were filed with and approved by the Secretary of State of Florida on the 26th day of March, 2001, and

WHEREAS, it is the intention of the sole member of PEREGRINE INTERNATIONAL, LLC that the Articles of Organization be amended in accordance with the Amendment to the Articles of Organization hereinafter set forth; and

"I hereby file these Articles of Organization as authorized representative of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida."

NOW, THEREFORE, the Articles of Organization of PEREGRINE INTERNATIONAL, LLC are hereby amended by deleting in its entirety the present Article III and by substituting therefor the following, to-wit:

## "ARTICLE III REGISTERED OFFICE AND REGISTERED AGENT

The street address of the limited liability company's initial registered office in Florida is 501 E. Kennedy Blvd., Suite 1700, Tampa, Florida 33602, and the name of its initial registered agent is Richard A. Jacobson."
