#### ARTICLES OF ORGANIZATION

## FIRST STEP MEDICAL, LLC

#### ARTICLE I - Name

The name of this limited liability company shall be FIRST STEP MEDICAL, LLC.

#### ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

#### ARTICLE III - Purpose and Powers
