Termination of Existence



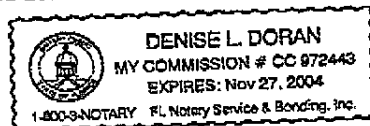
