**ARTICLES OF ORGANIZATION OF GAINESVILLE TOWING
LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Gainesville Towing, LLC".

ARTICLE II — Address of LLC and Registered Agent:

2.1 **Principal Office.** The mailing address and street address of the principal office of the Limited Liability Company is 400 NW 10th Avenue, Gainesville, Florida 32601.

2.2 **Relocation.** The Members may from time and time move the principal office to any other address in Florida.

2.3 **Registered Agent.** The initial registered agent of the corporation is JAMES H. WATSON, JR., and his business office and address is 400 NW 10th Avenue, Gainesville, Florida 32601.

ARTICLE III — Duration:

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV — Management:


ARTICLE V — Admission of Additional Members:




