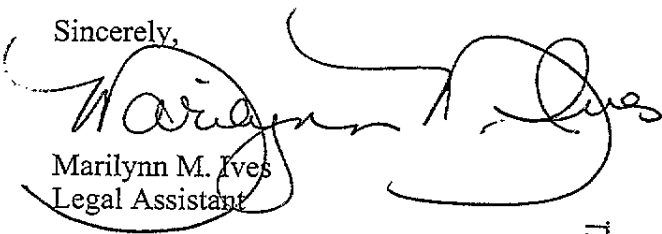

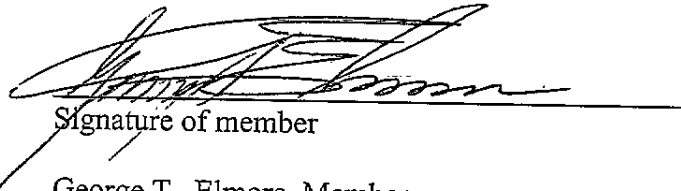
ARTICLE VII
