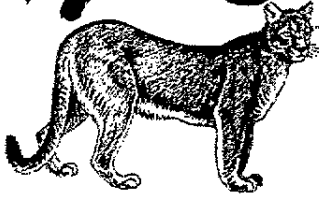

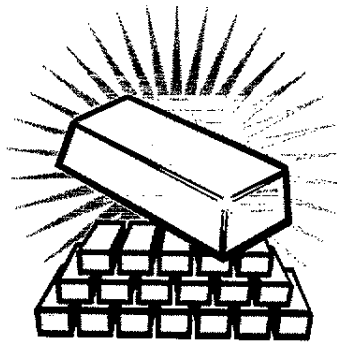

- 1.1 *The authorized representative files and executes the articles of organization for this Florida domestic limited liability company, pursuant to section 607.407 of the Florida Statutes.*




