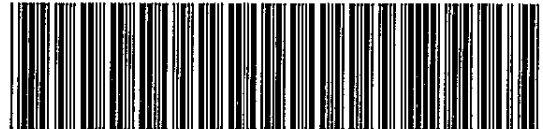



The amendment has been unanimously approved by the Managing Members of the Company who have the power to make all decisions pertaining to the management of the Company.



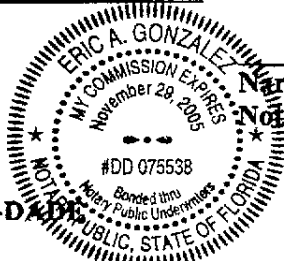

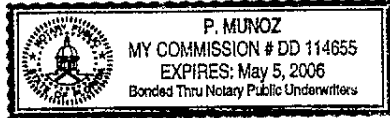
