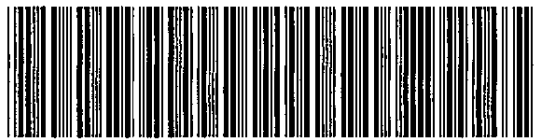

**ARTICLE VI - ADOPTION OF DISSOLUTION**


On June 8, 2009, at a duly constituted meeting, the dissolution was approved by all the managing members and members of this Company.


**ARTICLE VII - EFFECTIVE DATE**
