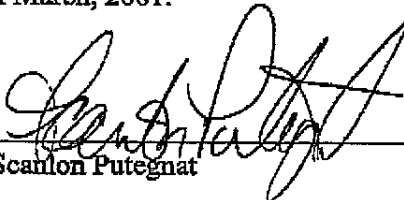
ARTICLE IV - MANAGEMENT

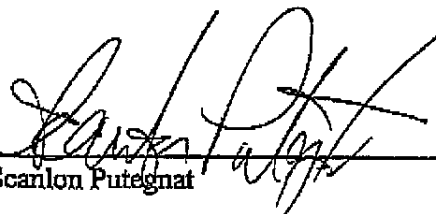
ARTICLE V - EFFECTIVE DATE
