ARTICLE IX - CONTINUATION OF BUSINESS OPERATIONS

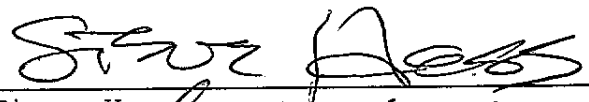

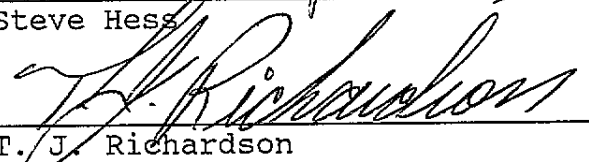
