ARTICLES OF CORRECTION/AMENDMENT TO ARTICLES OF ORGANIZATION OF FOUR SEASONS HOMEBUILDERS, L.L.C.

The undersigned, pursuant to Florida Statute 608.4115 of the Florida Limited Liability Company Act, hereby make, acknowledge, and file the following Articles of Correction/Amendment to the Articles of Organization originally filed on March 30, 2001. This correction is being filed to correct the address of the principal place of business and to correct the members names listed on Exhibit "A", as follows:

ARTICLE I - NAME

The name of the limited liability company shall be Four Seasons Homebuilders, L.L.C. ("Company"). The principal place of business of the Company in Florida shall be 402 Centre Street, Fernandina Beach, Florida 32034. The mailing address is the same.

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall terminate not later than December 31, 2050, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE VIII - TERMINATION OF EXISTENCE


