ARTICLES OF ORGANIZATION
of
PERVASIVE INTERVENTIONS, L.L.C.

ARTICLE I: NAME

The name of this limited liability company shall be PERVASIVE INTERVENTIONS, L.L.C. (the "Company").

The Company may admit new members through the written consent of the Company's members entitled to vote thereon in accordance with the manner set forth in the Company's Operating Agreement.

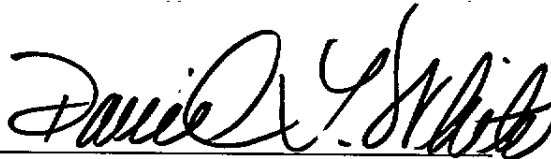
ARTICLE VIII: AMENDMENT OF ARTICLES OF ORGANIZATION
