

ARTICLES OF ORGANIZATION FOR

YellyFish, LLC

The undersigned individual of a limited liability company formed under the Florida Limited Liability Company Act hereby adopts the following Articles of Organization:

1. Name. The name of the limited liability company is YellyFish, LLC.
2. Principal Place of Business. The street address of its principal place of business and offices where notices can be sent in this state office is 525 Patrick Avenue, Merritt Island, Florida 32953-6136.

4. Management.
