NAME**

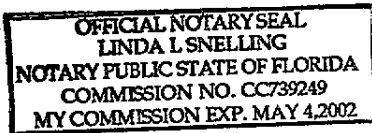


