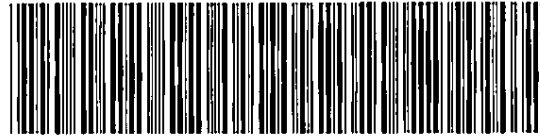

These Amended and Restated Articles of Organization for AZORRA PROPERTIES II LLC are being filed pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act and hereby amend, in their entirety, the Articles of Organization filed with the Florida Secretary of State on April 4, 2001 under Document Number L01000005235.

ARTICLE I – Name

The name of the limited liability company is Azorra Airport Holdings LLC (the “Company”).

ARTICLE III – Management


The Company shall be managed by its manager and is therefore, a manager-managed Company. The name of the current sole manager of the Company is Azorra Properties LLC.
