undersigned Subscriber hereby makes, subscribes, The acknowledges, and files with the Secretary of State of the State of Florida these Articles of Organization, for the purpose of forming a limited liability company, in accordance with Chapter 608, Florida Statutes, Florida Limited Liability Company Act.

#### ARTICLE I - NAME
