ARTICLES OF ORGANIZATION

OF

HIBOU INTERNATIONAL, LLC

a Florida limited liability company

- 1. The name of this limited liability company is **HIBOU INTERNATIONAL, LLC** (the "Company").

The foregoing right of indemnification shall not be exclusive of any other rights to which any member, manager, officer, employee or agent may be emitted as a matter of law or which he may be lawfully granted
