ARTICLES OF ORGANIZATION OF ROSS MATZ INVESTMENTS II, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Act, Chapter 608, Florida Statutes.

ARTICLE I NAME

ARTICLE VIII OPERATING AGREEMENT

The members may adopt, alter, amend, or repeal the operating agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

ARTICLE IX DATE OF EXISTENCE OF THE COMPANY

The existence of the Company will commence on the date of filing the Articles of Organization by the Florida Department of State.
