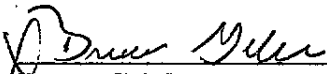

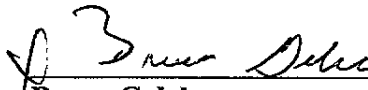
ARTICLE VI. MANAGERS

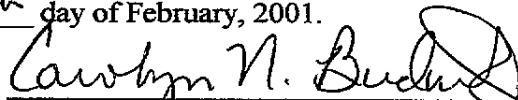
