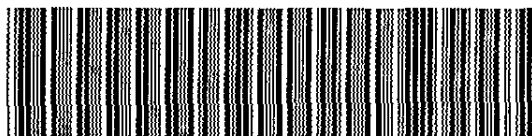

FIRST: The name and address of this corporation is **AMERICAN BOAT DELIVERY, L.C.**, 2395 Hanover Drive, Dunedin, Florida 34698.

SECOND: The date of the adoption of these Articles of Dissolution is 3 December 2002.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
