The name of the Limited Liability Company is Shoppes of Venice, LLC.

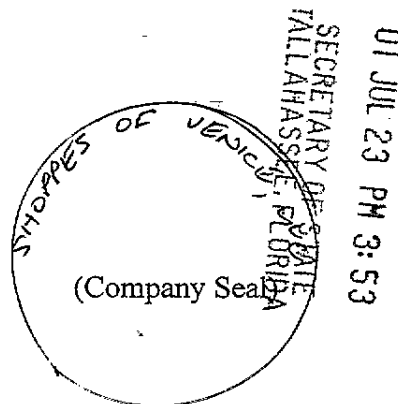

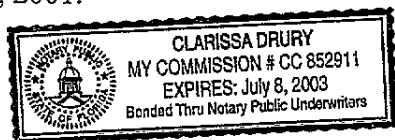
