ARTICLES OF ORGANIZATION of

LOGBOOM BAY, LLC

a Florida Limited Liability Company

ARTICLE I - Name:

The name of this limited liability company is Logboom Bay, LLC.

ARTICLE II - Period of Duration:

The limited liability company's period of duration shall be perpetual, commencing on the date of filing of these Articles of Organization.
