AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF M.C.D.P., Ltd. Co.

The undersigned, for the purpose of forming a limited liability company under the laws	of
Florida, hereby adopts the following Amended and Restated Articles of Organization:	

Article I Name

The name of the limited liability company is M.C.D.P., Ltd. Co. (the "Company").

Article II
Duration

This Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

encumber, transfer, assign and in all other ways dispose of, assemble, build, construct, operate, manufacture, place, cultivate, produce, market, and in all other ways (whether like or unlike the foregoing), deal in and with property of every kind and character, real, personal, or mixed, tangible, intangible, wherever situated and however held, including, but not limited to food, liquor, restaurant products, money, credits, choses in action, securities, stocks, bonds, warrants, certificates, debentures, mortgages, notes on commercial papers and other obligations and evidences of interest in or indebtedness of any person, firm or corporation (foreign or domestic) or of any government or subdivision, or agency thereof.

- C. Hire and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, principal or trustee.
- D. Promote or aid in any matter, financially or otherwise, any person, firm, association, or corporation, and to guarantee contracts and other obligations.
- E. Let concessions to others to do any of the things that this Company is empowered to do, and to enter into, make, perform and carry out, contracts and arrangements fo every kind and character with any person, firm, association, or corporation, or any government or authority or subdivision or agency thereof.
- F. To do all and everything necessary, convenient or proper for the accomplishment or improvement of any and all of the business, purpose, or object of, or attaining to the business, purpose, or object of, or in furtherance of any and all of the powers enumerated in these Amended and Restated Articles of Organization (including any and all amendments thereto) or the Operating Agreement for the Company, necessary or incidental to the protection or benefit of the Company as Principal, Agent, Director, Officer, Trustee, Legal Representative, or otherwise.
