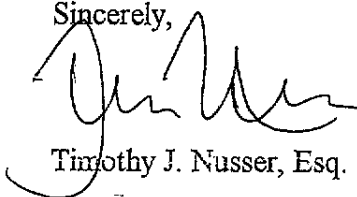

ARTICLES OF ORGANIZATION

OF

ARTICLE I. CORPORATE NAME.

The principal place of business and mailing address of the company is: 3916 N. Davis Highway, Pensacola, Florida 32503.

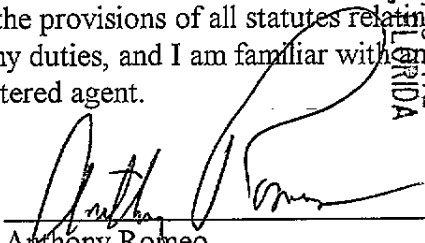
ARTICLE III. DURATION

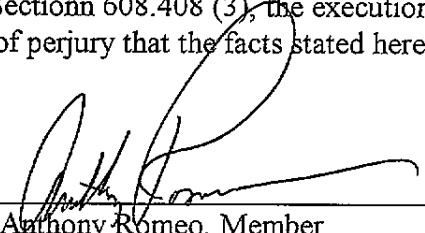
