**ARTICLES OF ORGANIZATION
OF
CRYSTAL IMAGE VIDEO PRODUCTIONS, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be Crystal Image Video Productions, L.L.C. ("Company"). The mailing address and street address of the principal office of the Company is 610 6th Lane, Greenacres, FL 33463.

**ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

(MANAGEMENT BY MEMBERS)**


The Company shall be managed by the members in accordance with regulations adopted


