ARTICLES OF ORGANIZATION OF****LFX, L.C.
(A Florida Limited Liability Company)****FIRST:** The date of filing of the Articles of Organization was April 6, 2001.**SECOND:** The following amendments to the Articles of Organization were adopted by the Company:

A. Article 4 is deleted in its entirety and replaced with the following:
