ARTICLES OF ORGANIZATION

OF

EVERPOINT PARTNERS, LLC

a Florida limited liability company

- 1. The name of this limited liability company is **EVERPOINT PARTNERS**, "Company").
- 2. The Company is being formed for the following purposes:
 - a. To engage in any and all lawful business or activity permitted under the kinds of the United States and the State of Florida.
 - b. To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
 - c. The foregoing right of indemnification shall not be exclusive of any other rights to which any member, manager, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.
