**ARTICLES OF ORGANIZATION  
OF

The undersigned members, acting pursuant to Chapter 608, *Florida Statutes*, hereby form a limited liability company in accordance with the laws of the State of Florida and adopt the following Articles of Organization for such limited liability company:



The Limited Liability Company is to be managed by one or more managers and is, therefore, a manager-managed company.


#### ARTICLE VI - PURPOSE
