MANAGEMENT**

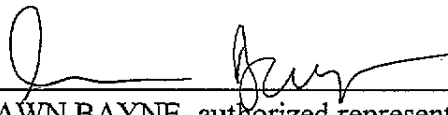
The Company is to be member managed. The rights and privileges of the managing members shall be set forth in the Operating Agreement.
