**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SARASOTA HEART CENTER, PL**

The undersigned, acting as the Manager of SARASOTA HEART CENTER, PL, hereby adopts the following Amended and Restated Articles of Organization pursuant to §608.411 of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes ("Act"), for the purpose of amending and restating the Articles of Organization of the company filed with the Florida Department of State on April 13, 2001:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company commenced on April 13, 2001, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The purposes of the company are to engage in the practice of medicine and any or all other lawful business for which a professional limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE X - TERMINATION OF A MEMBERSHIP INTEREST




ACCEPTANCE OF REGISTERED AGENT
