ARTICLES OF ORGANIZATION

OF

BOMAX LLC.

I hereby file these Articles of Organization as the authorized representative of the members of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I

NAME

The name of the limited liability company to be formed hereunder is "BOMAX LLC" (the "Company").





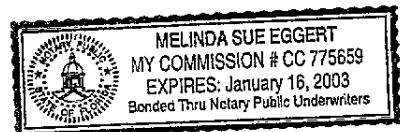
