ARTICLES OF ORGANIZATION OF DURAN INVESTMENTS, LLC  
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.407, Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be DURAN INVESTMENTS, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be 999 Brickell Avenue, Suite 700, Miami, Florida 33131.

SECOND: DURAN INVESTMENTS, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which DURAN INVESTMENTS, LLC is formed are:

- (A) to purchase, sell, distribute, invest in, import and export and otherwise deal with a variety of products within and outside the State of Florida;
- (B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.


**Designation and Acceptance of Registered Agent**
