Article 7. Amendment



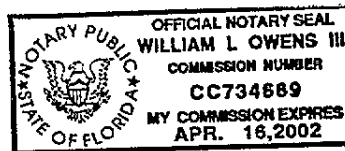


