### ARTICLES OF ORGANIZATION FOR EXCELETECH, L.L.C.

#### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer and a Member of EXCELETECH, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

#### ARTICLE I NAME
