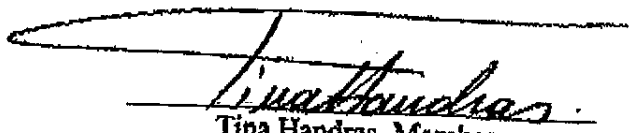
ARTICLE VI - MANAGEMENT
