

The undersigned, being desirous of forming a professional service limited liability company pursuant to Chapters 608 and 621, Florida Statutes, hereby certifies as follows:

1. Name of Limited Liability Company. The name of the limited liability company is Amma's Family Medicine, P.L. a Florida professional service limited liability company (the "Company").
2. Period of Duration. The period of duration for the Company shall be perpetual.


