

Article V. DURATION

This Limited Liability Company shall commence its existence on the date these Articles of Organization are filed with Florida Department of State. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in these Articles of Organization.

Article VI. PURPOSES AND POWERS
