These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

2. Duration. The Company shall have perpetual existence from the date of filing these Articles with the Department of State until occurrence of any of the events specified in Florida Statutes Section 608.441.

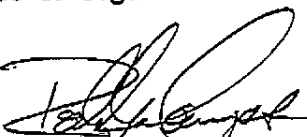
