The undersigned, being the organizer of the limited liability company named herein, hereby certifies that:

FIRST: The name of the limited liability company (hereinafter referred to as the "Company") is "BRIARWOOD GOLF PRACTICE CENTER, LLC".

SECOND: The latest date on which the Company is to dissolve is January 31, 2030.

THIRD: The purposes for which the Company is formed are:

- (a) To operate a golf practice center and driving range;
- (b) To carry on the business described above and any other related or unrelated business and activity in the state of Florida, in any state, territory, district or dependency of the United States, or in any foreign territory; and
- (c) To engage in any other lawful acts or activities for which limited liability companies may be formed within the State of Florida.

FOURTH: The address of the principal office of the company in this State is 5051 Radio Road, Naples, Florida 34104. *Mailing address is the same.*

SIXTH: The cash and value of property contributed to the Company is \$60,000.

SEVENTH: There are no agreed additional contributions to the Company.


EIGHTH: Additional members may be admitted to the Company upon payment of a capital contribution in a mutually agreed amount, in consideration of which such additional members shall receive a membership interest and voting rights proportional to their respective capital contributions.

NINTH: The Company shall be dissolved upon the happening of the following events: (a) When the period fixed for its duration has expired; (b) Upon the unanimous written agreement of all of the members; or (c) Upon the occurrence of an involuntary withdrawal of a member, unless

the remaining members, within ninety (90) days after the occurrence of the involuntary withdrawal, unanimously elect to continue the business of the Company.

TENTH: The Company shall be managed by a General Manager, whose name and address is C.W. Wayne Dahlstrom, 4239 Twenty Seventh Court, S.W., Unit 201, Naples, Florida 34116, and the Company therefore is a manager-managed company.


