

## Article VI. PURPOSES AND POWERS

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. ## ARTICLE IX. INDEMNIFICATION


V.D. Foundation of America, LLC shall indemnify any officer, director, or member of the Company to the full extent permitted by the law.
