# ARTICLES OF ORGANIZATION OF SARACENO AT PLANTATION ACRES, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be SARACENO AT PLANTATION ACRES, L.C. ("company").

## ARTICLE II -- ADDRESS


