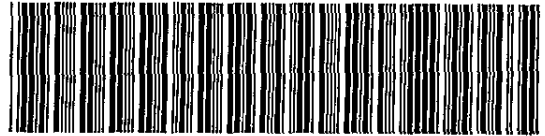


Article IX - Management is hereby deleted in its entirety and is replaced with the following, to-wit:
