**ARTICLES OF ORGANIZATION
OF
ROK INVESTMENTS, L.C.**

The undersigned member, desiring to form a Limited Liability Company under and pursuant to Chapter 608, Florida Statutes, entitled the Florida Limited Liability Company Act (the "Act"), does hereby adopt the following Articles of Organization for such company:

1. **Name.** The name of this limited liability company is ROK Investments, L.C. (the "Company").
2. **Duration.** The Company shall exist from the date of commencement stated in paragraph 3, below, until the earlier of (i) thirty (30) years from the date of commencement or (ii) the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the sole member.
3. **Date of Commencement of the Existence of the Company.** The existence of the Company shall commence on the date hereof.
4. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida and that are permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation where it may engage in business.
5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Christopher J. Klein. The street address of the initial registered agent of the Company is 21st Floor, New World Tower, 100 North Biscayne Boulevard, Miami, Florida 33132.
6. **Principal Office: Mailing Address and Street Address.** The street address and mailing address of the Company's principal office is c/o Roberto Kasinsky, 780 Harbor Drive, Key Biscayne, Florida 33149.
7. **Manager.** The Company is a manager-managed Company that will be managed by one Manager. The Sole Manager of the Company is its sole member, Roberto Kasinsky.

The undersigned, as sole member of the Company, executed these Articles of Organization on the 16 day of April, 2001.



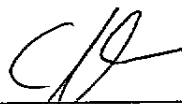
