The Limited Liability Company is to be a manager-managed company.

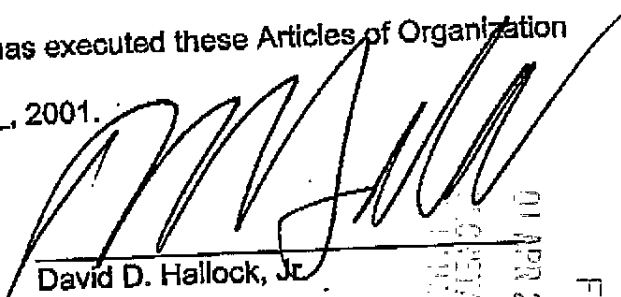
ARTICLE VIINITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

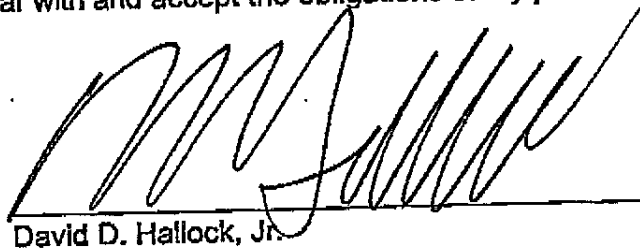
