**ARTICLES OF ORGANIZATION  
OF  
COASTAL SERVICES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be COASTAL SERVICES, L.L.C. ("L.L.C.").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the L.L.C. is 3000 Bee Ridge Road, Sarasota, FL 34239.

**ARTICLE III -- DURATION**

The L.L.C. shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The L.L.C.'s existence shall be perpetual unless the L.L.C. is dissolved earlier as provided in these articles of organization or in the regulations.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the L.L.C. is Thomas L. Randle, Jr., 3000 Bee Ridge Road, Sarasota, FL 34239.

**ARTICLE V -- CAPITAL CONTRIBUTIONS**

The Members of the L.L.C. shall contribute to the capital of the L.L.C. the cash or property set forth in Exhibit "A".

**ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS**

Each Member shall make additional capital contributions to the L.L.C. only on the unanimous consent of all the Members, or as provided in the regulations.

**ARTICLE VII -- ADMISSION OF NEW MEMBERS**

Except as set forth in the regulations, no additional Members shall be admitted to the L.L.C. except with the unanimous written consent of all the Members of the L.L.C. and

on such terms and conditions as shall be determined by all the Members. A Member may transfer his or her interest in the L.L.C. as set forth in the regulations of the L.L.C., but the transferee shall have no right to participate in the management of the business and affairs of the L.L.C. or become a Member unless all of the members of the L.L.C. other than the Member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The L.L.C. shall be dissolved on the death, bankruptcy, or dissolution of a Member or Manager, or on the occurrence of any other event that terminates the continued membership of a Member in the L.L.C., unless the business of the L.L.C. is continued by a majority vote of all the remaining Members.

#### ARTICLE IX -- MANAGEMENT

The L.L.C. shall be managed by the Members in accordance with regulations adopted by the Members for the management of the business and affairs of the L.L.C. These regulations may contain any provisions for the regulation and management of the affairs of the L.L.C. not inconsistent with law or these Articles of Organization.

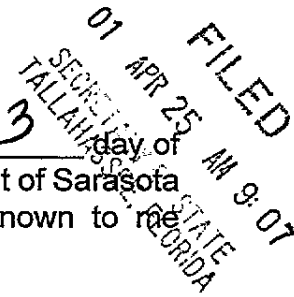
