ARTICLES OF ORGANIZATION

OF

PLAYHARD PROMOTIONS, L.L.C.

The undersigned incorporator to these Articles of Organization, a natural person competent to contract, hereby presents these Articles for the formation of a organization under Chapter 608 of the laws of the State of Florida.

ARTICLE I: NAME

The name of the organization is PLAYHARD PROMOTIONS, L.L.C.

ARTICLE II: EXISTENCE

- 2.1 Period of Existence: Unless dissolved earlier in accordance with law, this limited liability company shall dissolve on the date thirty (30) years following the date these Articles of Organization are filed with the Florida Secretary of State.
