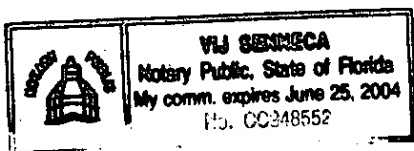
1. Elisa M. Mashali is the Manger of PRO AD, LLC, a Florida Limited Liability Company, (hereinafter "Company").
