ARTICLES OF ORGANIZATION
OF
OHC, LLC,
A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I

NAME

The name of this limited liability company is OHC, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

**PRINCIPAL OFFICE, MAILING ADDRESS AND
REGISTERED AGENT**

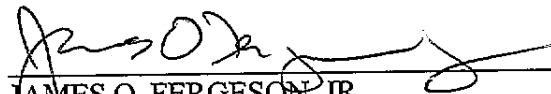
