These Articles of Organization of ALBERT SALEM, JR., ATTORNEY, L.L.C., a Florida limited liability company (the "Company"), dated as of the 1<sup>st</sup> day of January, 2001, are being duly executed and filed by Albert Salem, Jr., the organizer, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) (the "Florida Act").

**FIRST:** The name of the limited liability company is ALBERT SALEM, JR., ATTORNEY, L.L.C.

Attorney, L.L.C., Limited Liability Company Regulations (the "Regulations").




