ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

A/P, LLC

ARTICLE I.

The name of the Limited Liability Company is "A/P, LLC" (the "Company").

ARTICLE II. ADDRESS
